### Admissions Policy -- Administrative Procedures

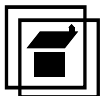
#### **I. Application Process**

- A. Applicants must attend an Information Session
- B. Applications for admission will be received after September of the applicant's eighth grade year.
- C. All applications must be complete and have all required signatures.
- D. The following supporting materials must be submitted:
  - 1. Transcript (Grade 7)
  - 2. Transcript (first marking period Grade 8)

#### **II. Acceptance Criteria**

- A. Applicants will be ranked according to the following scoring:

Grade Point Average – 7th grade	0-15
Grade Point Average – 8th grade (1st marking period)	0-15
Entrance Exam	
Mathematics	0-35
Language Arts	0-35
Total Possible	100
Minimum Score for Admission	65



### II. Acceptance Criteria (continued)

B. Ratings will be determined as follows:

#### II. Entrance Examination

An entrance examination will be administered in January or February of each year. The examination will consist of two sections, mathematics and language arts. Each section will be scored on a scale of 0-35.

III. All *performing arts Dance or Theatre applicants* who qualify academically must successfully audition to qualify for admission.

### III. Student Acceptance

If space does not permit acceptance of all qualified applicants who meet the acceptance criteria, selection will be made with the following considerations:

Each of the twenty-one municipalities in Union County submitting qualified applications will be granted at least two spaces in each 9th grade class of each school. Qualified applications will be defined as those meeting minimum standards as defined in the acceptance criteria. Additional students will be selected based on the next highest scores.



### III. Student Acceptance (continued)

If appropriate, the chief school administrator will establish a committee to assess qualitative criteria as an additional consideration to admission. The criteria will include, but not limited to, projects submitted or activities in which the applicant participated.

The Union County Vocational-Technical School District provides an equal educational opportunity to all students who meet the acceptance criteria regardless of race, color, age, creed, religion, sex, sexual orientation, ancestry, national origin, social or economic status, marital status or disabilities. In accordance with board policy, code and statutes, the high schools provide an equal educational opportunity to all students.
